### I. PURPOSE & SCOPE

# IV. IT IS MUTUALLY UNDERSTOOD AND AGREED UPON BY THE PARTIES THAT:

1. Modification : The programme undertaken shall be reviewed

Periodically and based on feedback received be modified, if required for optimal output and

administrative and operational convenience.

Extension : The period of MOU signed may also be extended if found mutually beneficial.

i. Any programme undertaken may be terminated after due evaluation and feedback, if found unproductive and untenable .

ii. The entire MoU can also be terminated anytime without being a burden for

any party, of course, with a minimum of three

months' notice from either side.

### V. MEETINGS AND REPORTING

To accomplish these objectives, the partners will meet at least Two (2) Times a Year for the purposes of programme planning and monitoring and evaluating the outcomes. Decisions at the meeting will be decided by consensus and be reported to the authorities concerned duly.

### FUNDING

This MoU shall not include any kind of reimbursement of funds between the two parties.
